



SENIOR EXEMPTIONS BENEFIT TABLE 2022

The chart below illustrates the **Senior Exemption** savings applied to the city and county taxes based on the **proposed millage rates**. It also illustrates the cities that adopted the **Long Term Resident Senior Exemption**. Please note, the Long Term Senior Exemption applies to all county taxes.

The Senior and Long Term Resident Senior Exemptions do not apply to certain taxing authorities (i.e. School Board & State).
