



## NW 7TH AVENUE CORRIDOR REDEVELOPMENT AGENCY REGULAR MEETING

#### OFFICIAL MINUTES – Wednesday, December 20, 2023

- I. Call to Order CRA Board Chairwoman Pierre called the meeting to order at 6:25 p.m.
- II. Roll Call and Introductions –

- III. Public Comment/ Reasonable Opportunity to be Heard Renita Holmes inquired about the boundaries of a CRA to which the Chairwoman stated that the boundaries Ms. Holmes was referring to were a different CRA. Ms. Holmes also touched upon the continued efforts to make sure the community is being informed and educated on any upcoming projects in the community.
- IV. Approval of Agenda Gene Lomando moved approval of the Agenda, with a second from Nadeige Theresias- Joisil. *Motion passed*.
- V. Approval of November 9, 2023, Minutes –Nadeige Theresias- Joisil moved approval of the Minutes, with a second from Gene Lomando. *Motion passed*.
- VI. Items for Review And/Or Action -
  - A. **RESOLUTION APPROVING THE NW 7TH AVENUE COMMUNITY REDEVELOPMENT AGENCY FISCAL YEAR 2023-2024 BUDGET IN THE AMOUNT OF \$6,921,843** – After an inquiry from Nadeige Theresias-Joisil regarding the budget, Anthony Bonamy from the District 2 Commissioner's Office stated that the budget reflects changes discussed in collaboration with the CRA, staff and the Commissioner's office. He also stated there are future plans to expand the boundaries of the NW 7<sup>th</sup> Avenue CRA. Terrence Smith clarified that a Finding of Necessity (FON) will have to be conducted prior to a recommendation for a boundary expansion. Further, he stated the estimated timeline for the whole process is around one year. A member of the audience inquired about the boundaries of another CRA, which Chairwoman Pierre stated that was a different CRA. Gene Lomando further clarified the difference between the two CRA boundaries. Nadeige Theresias-Joisil moved to approve the budget, with a second from Gene Lomando. *Motion passed*.
- VII. Discussion Items No discussion items were presented.
- VIII. New Business Economic Development Coordinator and Grants Coordinator Request for Proposals (RFP) Vivian Cao stated that the economic development coordinator RFP is under the cone of silence and there will be a kick-off meeting in January. The grants coordinator RFP will be released today, and the deadline is January 8<sup>th</sup>. Nadeige Theresias-Joisil had a question about the updating of the redevelopment plan, Terrence Smith stated the plan can be updated to include future projects and outdated plans can be removed. The current year's budget includes a line item to support the costs of updating the Plan.

#### RESOLUTION NO.

**RESOLUTION DIRECTING COUNTY MAYOR OR COUNTY** MAYOR'S DESIGNEE TO COMPETITIVELY SELECT A CONSULTANT TO PREPARE. AT THE SOLE COST OF THE NW 7TH AVENUE CORRIDOR COMMUNITY REDEVELOPMENT AGENCY, A FINDING OF NECESSITY STUDY FOR EXPANSION OF NW 7TH AVENUE CORRIDOR COMMUNITY REDEVELOPMENT AREA TO INCLUDE TWO GEOGRAPHICAL AREAS DESCRIBED **GENERALLY** BOUNDED ON (1) THE NORTH BY THE INTERSECTION OF STATE ROAD 9 AND THE STATE ROAD 9 RAMP, THE SOUTH BY THE CANAL NORTH OF SOUTH BISCAYNE RIVER DRIVE, THE EAST BY NW 7TH AVENUE, AND THE WEST BY STATE ROAD 9, AND (2) THE NORTH BY LITTLE RIVER CANAL, THE SOUTH BY NW 80TH STREET TO THE BOUNDARY OF THE CITY OF MIAMI. THE EAST BY NORTH MIAMI AVENUE, AND THE WEST BY NW 6TH AVENUE

WHEREAS, pursuant to chapter 163, Florida Statutes (the "Act"), a Finding of Necessity

study must be prepared in order to initiate the redevelopment process for areas believed to be slum

and blighted; and

WHEREAS, the Act confers all redevelopment powers upon counties with home rule

charters; and

WHEREAS, this Board adopted Ordinance No. 06-18, which established the N.W. 7th

Avenue Corridor Community Redevelopment Agency ("Agency") and appointed an initial Board

of Commissioners pursuant to section 163.356, Florida Statutes; and

WHEREAS, the Agency's responsibilities include the removal of slum or blight from the

community redevelopment area, which is more fully described in Exhibit "A" attached hereto and

incorporated herein by reference; and

WHEREAS, this Board wishes to consider expanding the current boundaries of the redevelopment area to include two areas as described generally as bounded on (1) the north by the intersection of State Road 9 and the State Road 9 ramp, the south by the Canal North of South Biscayne River Drive, the east by NW 7<sup>th</sup> Avenue, and the west by State Road 9; and (2) the north by Little River Canal, the south by NW 80<sup>th</sup> Street to the boundary of the City of Miami, the east by North Miami Avenue, and the west by NW 6<sup>th</sup> Avenue, ("proposed expanded area"); and

WHEREAS, the proposed expanded area is depicted in Exhibits "B" and "C" attached hereto and incorporated herein by reference; and

**WHEREAS**, this Board desires to authorize the County Mayor or County Mayor's designee to competitively select a consultant to prepare a finding of necessity study (the "study") for the proposed expanded area in accordance with the provisions of the Act; and

**WHEREAS,** in accordance with section 163.387 of the Act, the Agency may use monies in the redevelopment trust fund to pay for expenses related to the preparation of the study; and

WHEREAS, this Board wishes that the County Mayor or County Mayor's designee seek, on behalf of the County, to be reimbursed by the Agency for any expenses related to the preparation of the study,

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

<u>Section 1.</u> The foregoing recitals are incorporated in this resolution and are approved.

Section 2. This Board hereby directs the County Mayor or County Mayor's designee to competitively select a consultant to prepare a finding of necessity study (the "study") of two geographical areas as depicted in Exhibits "B" and C" attached hereto and incorporated herein by reference, and which such areas are described generally as bounded on (1) the north by the

intersection of State Road 9 and the State Road 9 ramp, the south by the Canal North of South Biscayne River Drive, the east by NW 7<sup>th</sup> Avenue, and the west by State Road 9; and (2) the north by Little River Canal, the south by NW 80<sup>th</sup> Street to the boundary of the City of Miami, the east by North Miami Avenue, and the west by NW 6<sup>th</sup> Avenue. The cost of the study shall be borne solely by the Agency.

The Prime Sponsor of the foregoing resolution is Commissioner Marleine Bastien. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was

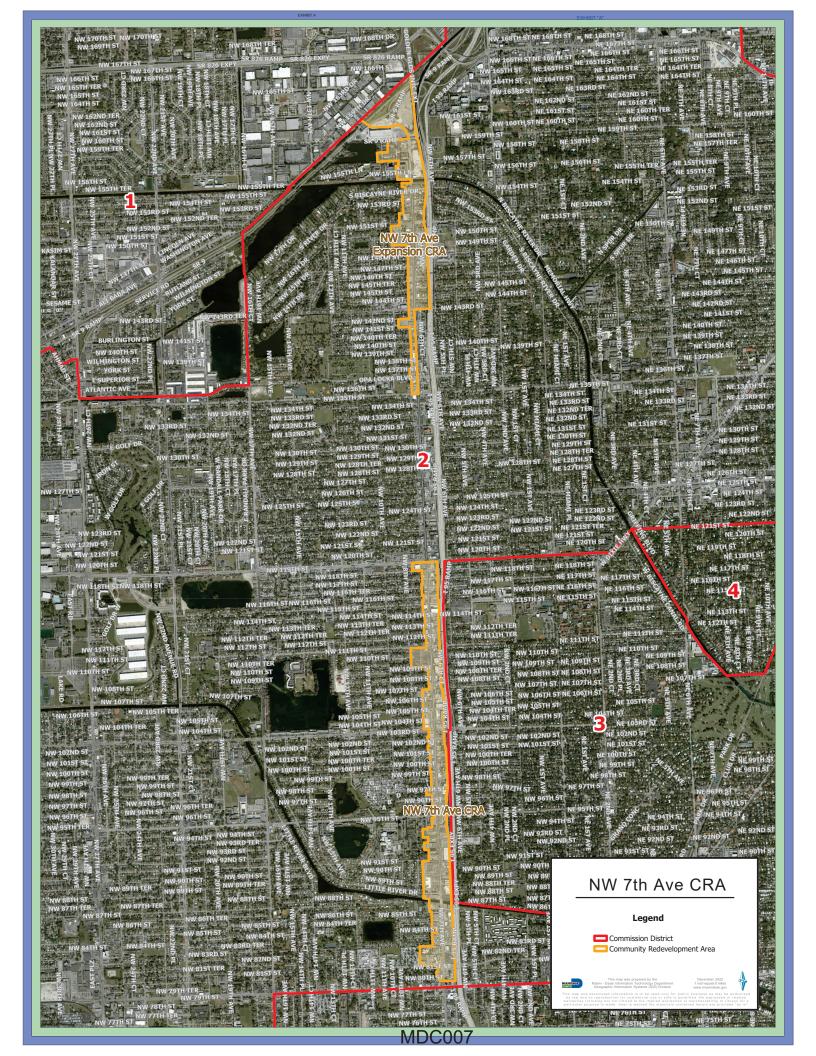

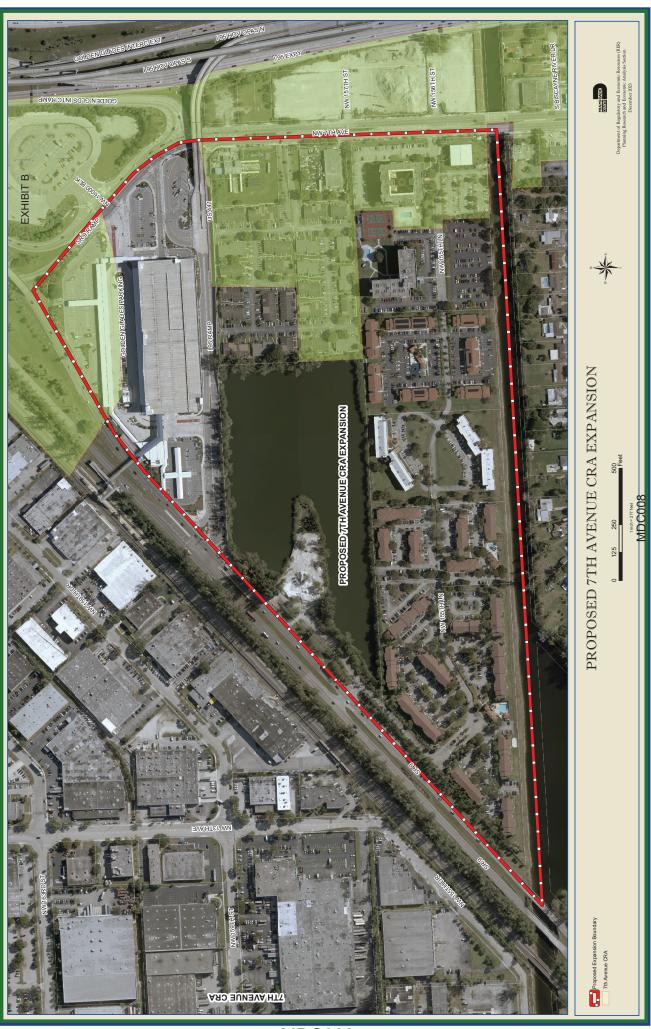
