Project Background





- Builds on 2018 Miami-Dade TPO Vision Zero Plan
- DTPW's 2021 Vision Zero Framework Plan outlined strategies for implementation
 - Comprehensive review of the major and minor roadway network
 - Plan envisioned a multi-agency collaborative effort towards achieving Vision Zero

What is Vision Zero?





Vision Zero is a strategy to <u>eliminate all</u> <u>traffic fatalities and severe injuries</u>, while increasing safe, healthy, equitable mobility for all. First implemented in Sweden in the 1990s, Vision Zero has proved successful across many US cities.

DTPW's Vision Zero goal is to eliminate fatal and serious injuries within our transportation network by 2040

Engage communities to expand awarenessFocus outreach events in high equity areas





MDC High-Injury Locations








2021 Vision Zero Plan

Potential High Injury Projects







Check out "How to Apply" webinars and other resources SYSTEM Learn more about integrating the Safe System Approach into your eligible Implementation Grant projects and strategies Step 2 Decide who will apply · Confirm that you are eligible to apply · Consider whether to apply individually or as part of a joint application with other eligible applicants Step 3 Start the process with SAM.gov SAM.GOV New applicants must obtain a Unique Entity Identifier (UEI). Applicants that previously had a DUNS number must confirm UEI. Joint Applications chose a single lead applicant with a single UEI. Step 4 Decide how to implement your plan Use your Action Plan to inform your implementation Determine which projects and strategies from your Action Plan to implement as part of this grant. Consider also pursuing supplemental action plan activities
